NOTICE OF LIABILITY

Thank you for the prompt response to my email of 30th June 2021 concerning Covid-19 advice on the Ceroc website at www.ceroc.com/119/ceroc-covid-news. I note you overlook the serious nature of the situation, the main points I raised in my email and that you dismiss my comments as mere opinion claiming this cannot be allowed to take precedent.

With regard to the principles you set out; working within the law, supporting your members wherever possible in pursuit of their dance career and keeping any private opinions in respect of politics and religion private. These are fine principles indeed but, as you should know, every one of your members and every citizen have a moral duty to respect the rights of fellow human beings and a moral duty to report criminal activity and not remain silent. Moreover, we all have a legal duty to refrain from supporting and /or engaging with any kind of criminal activity.

I therefore reiterate; there is no requirement for any individual, business or organisation to follow bad government advice. There are no rules, no regulations and no laws forcing you, as a business, to advise all your customers to vaccinate. And, you are certainly not qualified to offer me or any other person advice on medical matters.

You show no awareness of the fact that Covid-19 vaccines are killing and injuring thousands of people. Reports show more than 23,000 fatalities and more than 2,900,000 injuries in the UK, US & EU directly linked to vaccinations since being introduced in December 2020. The MHRA Yellow Card reporting scheme in the UK, VAERS in US and EudraVigilance in EU are supposed to act as early warning systems but the fatalities and injuries following immediately after vaccination are not being investigated. Efficacy of vaccines has already been shown to be less than 1.3% (refer [Lancet](#) report 20/4/21). The vaccines also pose a serious threat to health with a High Risk/ Low Benefit ratio as shown in a recent scientific study. And, the long term risks from the vaccinations are not yet known but the harm they can cause has already started to cause major chaos. For example, 4 British Airways pilots recently dropped dead shortly after vaccination, other pilots are suffering from adverse reactions and thousands of flights have been cancelled by many airlines due to a shortage of flight crew etc.

The evidence now available shows there was never any justification for Emergency Use Authorisation of the EXPERIMENTAL Covid vaccines. The facts

show that inexpensive treatment options for Covid-19 symptoms were ignored by government but these treatment options have proven to be very successful in other countries. Alarming, there is now substantial evidence revealing a FAKE pandemic created by inappropriate use of the PCR test, incorrect classification of deaths as Covid deaths, recording of deaths as Covid deaths simply because death occurred within 28-60 days of a positive test etc. All explained in the video via link below.

I am eager to join fellow dancers at future events and help Ceroc thrive and prosper for the benefit of all concerned but the position you take shows a selfish desire to survive and prosper at the expense of your members which, in my opinion, is morally corrupt.
