Dear Mr Thompson,

FINAL NOTICE OF LIABILITY

I refer to my email of 8th July 2021 (copy attached) concerning Covid-19 advice on the Ceroc website. I've not received a response from you but I see the Ceroc website has since been updated with more misleading, discriminatory and potentially deadly advice at <https://www.ceroc.com/122/covid-care>.

Apparently, you've ignored my email and all the facts and evidence that I referred you to. It also appears to me that you've ignored the evidence that has become available in the public domain since 8th July such as the open testimony of Dr David Martin explaining that Covid-19 is Patented GENOCIDE. The very credible evidence he presents shows that the [SARS-Cov-2 virus was designed and patented as early as 2002](#). Apparently, it was then intentionally released as a bio-weapon enabling introduction of the Covid-19 vaccines which seem to be designed to depopulate.

Furthermore, you appear to have ignored the staggering rise in deaths following, and directly linked to, vaccination with official reports now showing more than 32,000 deaths (1,490 in the UK, 18,928 in the EU & 12,313 in the US) together with approximately 3.5 million reported injuries. As explained in the video which I referred you to in my previous email, these figures are the tip of the iceberg. However, the hidden deaths caused by vaccination are slowly being revealed and one example of this can be found in a court case (US Civil Action No. [2:21-cv-00702-CLM](#)) raised on 19th July which shows evidence of at least 45,000 people that have died in the US almost immediately following vaccination, not 10,991 as the official reports showed at that period in time.

A Freedom of Information request has also revealed that [5,522 people died in Scotland](#) within 28 days of vaccination. The death toll thus far, caused by vaccination, probably already includes members of the dance community such as the sudden death of Audrey Whitton, a popular Dundee Ceroc member and a lovely lady who died prematurely on 17th May 2021.

Another two good reasons to question the Covid-19 vaccines are the toxic ingredients that have been discovered recently and the incredible phenomenon of vaccinated [people becoming magnetic](#) etc.

It is now blatantly obvious that **Covid-19 vaccines are NOT safe** and they are certainly **NOT effective** according to the facts available such as the scientific reports that I previously referred you to. Further reports also show that [vaccinated people are more likely to contract Covid-19](#), be hospitalised and die prematurely. Evidence published by the government in Gibraltar confirms that [vaccinated people are far more susceptible](#) to Covid disease. The inventor of mRNA vaccines, Dr Robert Malone, is also on record saying that [vaccines can cause the virus to be more dangerous](#). The undeniable fact is that Covid-19 vaccines are an experimental drug which is effectively a poison, killing tens of thousands of people and injuring millions. However, despite all this evidence you continue to advise dancers to be vaccinated.

I therefore regard your lack of response and the actions of Ceroc management to be the epitome of ignorance, verging on evil, since your intention is to discriminate by introducing the NHS Covid pass at venues despite the fact that certification is **not** mandatory. Moreover, this may be illegal and news reports show that night club venues are preparing to raise a [legal challenge](#) on this matter. But where is **your** resistance to the tyranny and dystopian nightmare which the UK government is driving towards?

For your information, the Public Admin and Constitutional Affairs Committee of the UK parliament, responsible for the Covid-Status Certification Review, received more than 9000 written responses from the public and they considered evidence on the matter. They then issued a [stinging report](#) over the government's handling of matters and actually recommended against Covid certification. However, you have obviously ignored this fact since the Ceroc website now provides a link to a **very** deceptive report issued by government which completely ignores the parliamentary committee report and shows incredible contempt for that committee.

Clearly, you are wilfully supporting a rogue UK government that is now out of control led by liars, cheats and charlatans. As you will know, judicial reports have already shown us that Boris Johnston PM is a liar, Matt Hancock MP is a liar, Robert Jenrick MP is a liar and Nicola Sturgeon FM is a liar.

These proven liars in government together with their fellow deceivers have failed in every respect to show **any** indisputable evidence to support their actions over the past 16 months. The current UK government cannot be trusted and anyone who calls them out is silenced, evidenced recently by MP Dawn Butler who called out Boris Johnston for his lies and was then ordered to leave the House of Commons. I therefore suggest that only a deluded fool would believe the liars in government over the vast number of very credible and distinguished experts who show valid evidence and recommended against vaccination.

So Mr Thompson, are you a deluded Fool or a Deceiver?

I give you the benefit of my doubt and reiterate; there is no requirement for any individual, business or organisation to follow bad government advice. There are no rules, no regulations and no laws forcing you, as a business, to advise all your customers to vaccinate, to test regularly or for you to request certification as proof of entry to any establishment.

Once again, I urge you to carefully consider all the important facts that I have referred you to. However, if you are foolish enough to ignore the facts now available but persist in supporting the government's rollout of the experimental Covid-19 vaccines and vaccine certification in any form, then I will consider you to be complicit in crimes against humanity. And, I will do whatever is possible within my power and the limits of the law to stop you and your organisation from supporting a rogue government, giving bad advice and implementing discriminatory passes at any Ceroc venue. This Notice of liability applies to you and all franchise holders in the Ceroc organisation.

While bad Covid advice on the Ceroc website remains active, I believe any teachers, dancers and other members of Ceroc who participate and support upcoming events under these conditions will show their ignorance of the facts and an uncaring attitude for civil liberties and freedom which our ancestors fought and died for. Moreover, compliance with discriminatory identification methods such as the NHS Covid pass will, in my opinion, reveal uncaring attitudes, discriminatory intent and contempt for fellow human beings.

Following orders, instructions or advice is no excuse for being complicit in crimes against humanity. Therefore an appropriate response from you will be the immediate removal of all bad Covid-19 advice from the Ceroc website concerning vaccination, regular testing and the discriminatory NHS Covid pass. It would also be helpful if you started to resist, instead of complying with, unlegislated tyrannical guidance that comes from Boris Johnston and his cronies. If the above changes are made to the Ceroc website within the next 14 days, it will be appreciated and I will then offer whatever assistance I can to ensure that Ceroc thrives and prospers.

Please note this final request is an open letter that I will be posting publicly for the purpose of general awareness and recording of evidence.
