### **Milton Keynes Family Funeral Services**

I refer to your letter of 16<sup>th</sup> September addressed to Mr John O'Looney of Milton Keynes Funeral Services and your suspension of his membership from SAIF on the basis of alleged misconduct because of his publication of tweets and videos on the subject of Covid 19.

I don't know Mr O'Looney personally but I have watched his videos concerning funeral services during the alleged Covid 19 pandemic and, in my opinion, he has conducted himself in a very professional and compassionate manner. I therefore commend him for his integrity and standards of public service.

The publicly available interviews that John has undertaken show considerable support and praise for what he has said and done. One video in particular on the Bitchute video channel has thus far received more than 835,566 views with 7,231 👍 LIKES & only 38 👎 DISLIKES (See Reference #1&2 below).

Most if not all comments on these videos are very supportive of his views and I have certainly found John's comments and his actions to be completely appropriate for the incredible situation that we are all faced with.

In contrast, the content of your letter shows a complete ignorance of the situation relating to Covid 19 and your decision to suspend Mr O'Looney's membership of SAIF seems completely inappropriate and unjustified.

You appear to be unaware of the fact that governments in the UK and elsewhere in the world are now accused of Genocide and Mass Murder by numerous distinguished experts, a response that has been triggered by the vast number of deaths following vaccination etc. As you should be aware, this controversial situation is not being properly investigated or reported by main stream media but if you care to investigate you will find overwhelming evidence justifying the admirable actions of Mr O'Looney.

In the first instance, I suggest you listen to the summary statement given by the German Lawyer, Dr. Reiner Feullmich of the German Corona Investigative Committee who interviewed and recorded the testimonies of more than 150 distinguished experts on the subject of Covid 19.

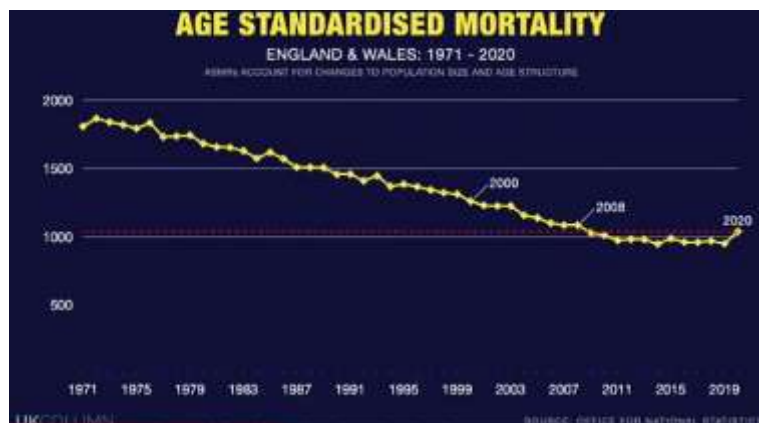

Thirdly, I suggest you read the official yellow card reports published weekly by the MHRA which confirm more than 1,645 deaths following vaccination in the UK. Moreover, I suggest you consider official reports that now show at least 30,305 deaths within 21 days of vaccination in England and more than 5,522 deaths in Scotland within 28 days of vaccination during the first 6 months of 2021 according to ONS and PHS Data.

The evidence against your actions and what you've said in your letter is overwhelming. And, if you care to investigate you'll find that everything Mr O'Looney has said concurs with official data released by government and local authorities throughout the UK. In particular, the Age Standardised Mortality data from the Office of National Statistics clearly shows the number of deaths in 2020 was less than the total number of deaths in any year prior to 2008.



The Covid death toll pushed out by government is extremely misleading but an estimate of the real Covid death toll is explained by Iain Davis in his article titled “A Deceptive Construction - Why We Must Question Covid-19 Mortality Statistics” Refer; <https://www.ukcolumn.org/article/deceptive-construction-why-we-must-question-covid-19-mortality-statistics>

Numerous Councils have already confirmed there were no excess deaths in 2020. For example, Cornwall Council confirmed in response to a Freedom of Information (FOI) request that they had less burials and cremations in 2020 than 2018, 2017, 2016 and 2015. Swansea Council also confirmed a similar situation in response to a FOI request. (See Reference #3&4 below)

Of course there will be some Funeral Services that were busier than normal in 2020 and some Council areas where excess deaths were reported but overall the evidence is now stacked up against government and their handling of Covid-19. Their Justification for emergency powers, lockdowns, social distancing, masks, vaccines and vaccine certification has effectively disappeared.

The facts show there was no pandemic in 2020 but there certainly seems to be a pandemic now with deaths following vaccination. The facts show that government is ignoring all relevant evidence and instead of investigating concerns raised by distinguished experts, the government have attempted to silence the experts who raise concerns. Since the government has effectively denied covid patients inexpensive preventative treatments to combat symptoms, and pushed out expensive ineffective vaccines as the only solution, it is now obvious that they are acting in a manner tantamount to Tyranny, Mass Murder and Genocide.

Your ignorance of the situation and the course of action you've taken casts a dark shadow over the SAIF organisation and shows that you may be, at best, foolish but your continued denial of this incredibly controversial situation will show complicity in the crimes against humanity perpetrated by government.

I would urge all SAIF members to follow the example of Mr O'Looney and report their situation openly and honestly because any SAIF member who stays silent on this incredibly serious matter may inevitably be considered complicit in crimes against humanity.


